Permission to Use the Facilities - The facilities and activity programs offered by On The Line Tennis LLC (OTLT), have been designed and established to provide the optimum level of beneficial exercise and enjoyment without compromising the health or safety of the players who utilize the facilities or participate in its activities. Because of the nature of these programs and of the equipment utilized, there is an inherent risk of injury. Therefore, any exercise activity places a practical limitation on the ability of OTLT to prevent injuries to participants regardless of the activities of the participant while taking advantage of the opportunities at OTLT. The undersigned acknowledges the individual responsibility to minimize risk by thoughtful and cautious use of the programs, equipment, and the facilities of OTLT.

Therefore, in consideration of being allowed to participate in OTLT programs and to utilize equipment and facilities at OTLT, I the undersigned, acknowledge and agree that:

- The risk of injury from the activities involved in OTLT programs, equipment and facilities is significant, including the potential for permanent paralysis and death.
- I knowingly and freely assume all such risks, both known and unknown and assume full responsibility for my participation.
- I willingly agree to comply with terms and conditions for participation. If I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest OTLT representative immediately.
- I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless OTLT, its members, managers, officers, officials, agents and/or employees, other participants, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event (releasees), from any and all claims, demands, losses, and liability arising out of or related to any injury, disability or death I may suffer, or loss or damage to person or property, to the fullest extent permitted by law.

On my behalf, and behalf of my child(ren), I hereby release, covenant not to sue, discharge and hold harmless OTLT and its employees, agents and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.
